THIS INCLUDED REHOUSING AND REPACKING MUCH OF THE MUSEUMS PRINT COLLECTION AND PHOTOGRAPHING PREVIOUSLY UNDOCUMENTED WORKS TO UPDATE THE MUSEUM'S DATABASE SYSTEM.
